- i. **General Revenue** – Total Revenue increase is 6.03%.  
ii. **Tax Increment District Funds** – Numbers not firm until the County and Schools submit theirs.  
iii. **Capital Projects Fund** – Capital Works Improvement Projects for 2026 include Industrial Park Resurfacing, Grand Ave. and 5<sup>th</sup> Street Reconstruction, and Annual Chip Seal. Funds from previous year to cover water truck, elevated tank repaint, well #4 rehab, plow truck and fire station repairs.  
iv. **Sauk Prairie Transit Fund** – Received one submittal for RFP, Brown Cab. Prairie du Sac allocation is \$18,000.  
v. **Sauk Prairie Municipal Court** – Prairie du Sac Allocation is \$14,401.

Ordinance No. 6, Series 2025, Amending Official Zoning Map Re: 4.57 Acres consisting all of current parcel #028-0024-00000 and part of current Parcel #028-0023-00000** – Applicant requesting to rezone property including 4.57 acres to rural residential to create a buffer to new development.
