1. Commencing work prior to issuance and paying for a building permit will result in doubling of all building permit fees and possible work stoppage order, citations and fines.
2. Park Land and Recreation Improvement Impact Fees shall be paid at the time of issuance of each building permit, except that a development agreement under Section 10-1-1006 or under 10-3-0703 of the subdivision and land division regulations may specify fee payment at an earlier date. The term "building permit" shall not include permits required for remodeling, rehabilitation, or other improvements to an existing structure, or for rebuilding or replacing a removed, damaged, or destroyed structure, where no increase in the number of dwelling units results.
