**ORDINANCE TO ADOPT AN UPDATE TO
THE SAUK PRAIRIE COMPREHENSIVE PLAN**

WHEREAS, the Village of Prairie du Sac is authorized to adopt a comprehensive plan as defined in sections 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes; and

WHEREAS, on November 16, 2005, the Village of Sauk City Board, Village of Prairie du Sac Board, and Town of Prairie du Sac Board jointly adopted the Sauk Prairie Comprehensive Plan (hereinafter "Plan") as each municipality's comprehensive plan, under Section 66.1001(4), Wisconsin Statutes; and

WHEREAS, the three Boards amended the Plan in 2012 and 2013, and with their 2012 actions also adopted the Highway 12/PF/Airport Area Plan as the first addendum to the Plan; and

WHEREAS, in 2015, the three Boards adopted the Sauk Prairie Comprehensive Outdoor Recreation Plan (CORP), with the intent that the CORP would later be incorporated as a second addendum to the Plan; and

WHEREAS, Section 66.1001, Wisconsin Statutes, requires that the Plan be updated at least once every 10 years, and establishes the required procedure for such an update; and

WHEREAS, per the procedures in Wisconsin Statutes, the 2005 Plan, and a 2009 intergovernmental agreement among the municipalities, the Sauk Prairie Intergovernmental Planning Committee (IPC) and the individual plan commissions have the authority and responsibility to recommend an update to the Plan; and

WHEREAS, such proposed update to the Plan have been duly considered by the Villages and Town, primarily through the IPC, using the procedures described in the Plan and the communities' adopted public participation process to update the Plan; and

WHEREAS, on October 19, 2016, the IPC recommended adoption of an update to the Plan, to be comprised of Volume 1—Conditions and Issues and Volume 2—Vision and Directions; and

WHEREAS, the Plan Commission of Village of Prairie du Sac on March 6, 2017 also recommended to the Village Board the adoption of said update to the Plan; and

WHEREAS, the Village has held at least one public hearing on this ordinance, in compliance with Section 66.1001(4)(d), Wisconsin Statutes, and following such hearing considered public comments and the recommendations of the IPC and Village Plan Commission.

NOW, THEREFORE, BE IT RESOLVED that the Village Board of Prairie du Sac, Wisconsin, does ordain that it adopts the Sauk Prairie Comprehensive Plan, comprised of

Volume 1—Conditions and Issues and Volume 2—Vision and Directions, each subtitled “Public Hearing Draft: January 2017,” with such volumes completely replacing the 2005 Sauk Prairie Comprehensive Plan.

BE IT FURTHER RESOLVED that the Village Board readopts the 2015 Sauk Prairie Comprehensive Outdoor Recreation Plan as the second addendum to the Sauk Prairie Comprehensive Plan, which together with the Highway 12/PF/Airport Area Plan shall be the two addenda to the Comprehensive Plan.


