ORDINANCE AMENDING SECTION 8-1-13
THROUGH STREETS DESIGNATED

The Village Board of the Village of Prairie du Sac, located in Sauk County, Wisconsin, do ordain as follows:

SECTION ONE: Section 8-1-13 of the Village Code of Ordinances is hereby amended, to read as follows:

SEC. 8-1-13 THROUGH STREETS DESIGNATED.

- (a) STATUTORY AUTHORITY. In the interest of public safety and pursuant to Section 349.07, Wis. Stats., the streets or portions thereof set forth in this Chapter are declared to be through highways, and traffic signs or signals giving notice thereof shall be erected by the Superintendent in accordance with Chapter 8-1-2.
- (b) EAST-WEST THROUGH STREETS DESIGNATED. The following are east-west through streets:
- (1) ~~Prairie Street from the west curblines of Water Street to the west corporate Village limits;~~
 - ~~(2)~~ Galena Street from the west curblines of Water Street to the east curblines of Third Street (One-way to the west); west curblines of Third Street to east curblines of Fifth Street; and from the west curblines of Fifth Street to east curblines of Ninth Street;
 - ~~(3)~~ Washington Street from the west curblines of Water Street to the east curblines of Fifth Street, and from the west curblines of Fifth Street to the east curblines of Seventh Street, and from the west curblines of Seventh Street to the east curblines of Ninth Street;
 - ~~(4)~~ Broadway from the west curblines of Water Street to the east curblines of Seventh Street; west curblines of Seventh Street to the east curblines of Thirteenth Street; west curblines of Thirteenth Street to the west corporate Village limits; east curblines of Lueders Road;
 - ~~(5)~~ Lincoln Avenue from the west curblines of Water Street to the east curblines of First Street and from the west curblines of First Street to the east curblines of Fifth Street and from the west curblines of Fifth Street to the east curblines of Ninth Street. Grand Avenue from the west curblines of Water Street to the east curblines of Fifth Street, and from the west curblines of 5th Street to the east curblines of 9th Street, and from the west curblines of 9th Street to the west curblines of 13th Street, and from the west curblines of 13th Street to the east curblines of Lueders Road.
- (c) NORTH-SOUTH THROUGH STREETS DESIGNATED. The following are north-south through streets:
- (1) Fifth Street from the south curblines of Prairie Street to the north curblines of Broadway, from the south curblines of Broadway to the north curblines of Grand Avenue, and from the south curblines of Grand Avenue to the south corporate Village limits;
 - (2) Seventh Street from the south curblines of Water Street to the north curblines of Prairie Street, and from the south curblines of Prairie Street to the north curblines of

- Broadway, and from the south curbline of Broadway to the north curbline of Grand Avenue, and from the south curbline of Grand Avenue ~~to the south curbline of Ray Street;~~
- (3) Ninth Street from the south curbline of Prairie Street to the north curbline of Broadway, and from the south curbline of Broadway to the north curbline of ~~Grant~~ Grand Avenue, and from the south curbline of Grand Avenue to the north curbline of Ray Street, and from the south curbline of Ray Street to the ~~south corporate Village limits~~ north curbline of Oak Street.
- (4) Thirteenth Street from the south curbline of Tower Street to the north curbline of Prairie Street; south curbline of Prairie Street to the north curbline of Broadway Street; south curbline of Broadway Street to the north curbline of Grand Avenue; south curbline of Grand Avenue to the south corporate Village limits.


SECTION TWO: This ordinance shall become effective following the date of its enactment and publication in the manner provided for by law.
